The Scout Association's Child Protection and Safety Policies

The Badger Hill Scouts Group Executive Committee are required by the Scout Association to bring to the attention of all organisations using the Badger Hill Scout Group facilities the Association's child protection and safety policies and get a simple declaration signed to this effect prior to a visit.

1 Overriding Controls

The Group Executive Committee or their appointed member has an overriding authority to direct that any particular activity shall be postponed, stopped or cancelled if, in their view, it is essential in the interests of safety.

2a The Child Protection Policy of the Scout Association

It is the policy of the Scout Association to safeguard the welfare of all members by protecting them from physical, sexual and emotional harm.

All adults within Scouting are responsible for the operation of the Association's Child Protection Policy. It is the responsibility of all adults to ensure that

- Their behaviour is appropriate at all times
- They observe the rules established for the safety and security of young people
- They follow the procedures following suspicion, disclosure or allegation of child abuse
- They recognise the position of trust in which they have been placed and,
- In every respect, the relationships they form with the young people under their care are appropriate.

Note the guidelines "Young People First" set out a code of practice essential for all adults in Scouting to follow; these are displayed in the entrance hall of the Hut.

2b The Safety Policy of the Scout Association

It is the policy of the Scout Association to provide Scouting in a safe manner without risk to health so far as is reasonably practical. The Association believes that this responsibilities incumbent upon providing Scouting activities and functions.

- It is the responsibility of all those involved in Scouting to seek, as far as is reasonably practical to
 ensure that
- All activities are conducted in a safe manner without risk to health of participants
- The provision and maintenance of equipment and buildings for members and others is safe and without risk to health and adequate for their welfare
- Information, instruction, training and supervision is provided with the object of ensuring the health and safety of all those involved in Scouting activities or who may be affected by them
- Appropriate arrangements are made to ensure safety and the absence of risks to health in connectionwith the use of transport, storage and handling of equipment and substances which are potentially dangerous.

3 The Scout Association internal rules and good practice

- All participants in activities must have received proper training, be suitably equipped and briefed about the
 nature and scope of the activity, be of an appropriate age and be subject to authorised supervision
- For young people under the age of eleven years old there must be a ratio of one adult to six young people
- For young people under the age of eight years it is highly recommended that for indoor activities there should be a ratio of one adult to six young people and for outdoor activities a ratio of one to four
- Group/Party leaders must be aware of the need to supervise all members in their charge in the locality of the activity being undertaken, including those not actively involved in the activity.

- iv. By signing this declaration, I am giving permission for my details to be passed to another organisation in the event of any issues arising from this booking
